Staying safe while shopping online

THE HOLIDAY season is upon us once again, and that means it's time get busy shopping.

For more and more of us, that means shopping from the comfort of our homes.

Retail e-commerce is thriving and growing rapidly. While consumers enjoy the convenience, selection and pricing of buying online, shopping over the internet is not without its drawbacks — cyber threats topping the list.

The good news is that there are a number of ways you can protect yourself while shopping online this holiday season.

Be aware of shopping-related phishing schemes. Phishing emails encourage you to click on a malicious link, typically by enticing you with a "deal" or exclusive price. If you click on the link, you're redirected to a spoofed landing page of the brand being impersonated. If something smells phishy, you can check the "from" email address to ensure it's legitimate or try hovering your mouse over the URL before you click to confirm that it leads to a legitimate site.

Beware of courier spam emails. This is one of the shipping scams that's common during the holiday shopping season, especially around Black Friday and Cyber Monday. If you're expecting any packages, you're a good target for scammers. You are likely to receive an email that looks like it's from the U.S. Postal Service, FedEx, or DHL. The email can be a notification of package arrival or delivery failure. The email may contain other links that request or confirm your personal and payment information. Some may also tell you to take immediate action to avoid penalties.

Avoid suspicious or unfamiliar retailers. Do not submit your login or payment information on any site that seems suspicious or offers deals that seem too good to be true. During the holiday season, scammers will set up sites designed to attract bargain hunters hoping to score crazy deals. If you aren't familiar with the website or company you are buying from, don't take the risk.

Keep an eye on your credit. Sometimes you may not even be aware that your personal information is compromised until it's too late. Holiday season is like hunting season for cyber criminals seeking personally identifiable information. If your information or identity is stolen, one of the first signs is unusual changes to your credit score. You can receive a free credit report from each credit bureau annually. Visit www.annualcreditreport.com for more information.

Ship to a secure location. Package theft has become more prevalent in recent years with the rise of online shopping and the barrage of home deliveries. If no one's home during the day, consider shipping to your office or somewhere else that keeps your packages off sidewalks or front doorsteps.

Secure accounts with strong passwords. Reusing passwords is like using the same key for your house as you do for your car, your office, your mailbox, and even the locker at your (continues on page 14b)

Claverack helps members save even more when buying Energy Star appliances

TO ENCOURAGE members to practice energy conservation and responsible energy use, Claverack offers rebates of up to \$100 to consumer-members who purchase qualifying Energy Star appliances.

With Claverack's Energy Star rebate program, members not only benefit from the energy savings achieved from the product itself, they receive a direct rebate from the co-op for their purchase. For Energy Star-rated refrigerators, the rebate amount is \$100; for washers or dryers, members will receive a \$50 rebate.

To apply for the rebate through the Claverack Energy Star Rebate Program members must:

- Purchase an Energy Star-rated refrigerator, washer or dryer in the current calendar year.
- Complete a rebate form, which can be found on the Claverack homepage, claverack.com, or by calling the office at 1-800-326-9799.
- Include a receipt or invoice showing the date and purchase price of the Energy Star items.
- ▶ Include a copy of the Energy Star

(continued from page 14a) gym that you never go to. The point is, if someone gets access to any one of those keys, they now have access to everything you want to keep safe. The same is true of your online accounts. During the holiday season, you'll likely be creating new accounts to make checkouts, tracking and returns easy. When you do, use random, strong passwords, so in the event of a site breach, you won't be handing a cyber criminal the key to your other accounts.

If you follow the tips laid out above, you'll be way ahead of the curve in terms of securing your personal information online and ensuring that your holiday season remains a time for joy, family and giving, instead of a time for worry, stress and frustration.

Co-op Connections Card: Your prescription for savings

One of the most valuable features of your Co-op Connections Card is the prescription discount offer. The card is your ticket to savings of up to 10 to 85% at over 60,000 participating pharmacies, including CVS, Rite Aid, K-Mart, Wal-Mart, Wegmans, Walgreens, Tops and Target — as well as many independent pharmacies.

Last year, Claverack members saved \$6,000 in prescription costs by

showing their Connections cards at participating pharmacies. Members saved an average of 49% off the retail price of their prescription purchases by

simply showing their Co-op Connections Card in 2018.

Since we began participating in the Co-op Connections program in 2011, Claverack members have saved over \$93,000 in prescription drug costs.

Be aware of third-party payment agencies when paying your Claverack bill

We all have bills to pay, and convenience and security when making those payments is important to everyone. We offer multiple secure payment options to our Claverack members, free of charge:

1) Send a check with your bill stub via the U.S. Postal Service.

2) Visit our Wysox office to pay by cash or check during regular business hours or after hours in our secure drop box.

3) Pay by phone using a check or debit/credit card with our automated system: 1-877-853-6463.

4) Pay online using a check or debit/credit card with SmartHub: claverack.com (Pay Bill). The SmartHub mobile app is available to iOS and Android users.

5) Set up automatic payments with the PAiD Plan so your payment is automatically posted on the due date each month. You set this up through SmartHub at our website.

Recently, some of our members have been utilizing third-party payment agencies to make payments to their Claverack account. We'd like to point out a few things you should know if you choose to make your payment this way. First, a processing fee may be applied to your transaction by the agency. Second, although the payment may be withdrawn from your bank account the day you initiate the transaction, the agency may be sending a paper check to our office, which could delay the posting of your payment by the due date, resulting in a late fee being applied to your account. Finally, although the agency website may display the Claverack logo, claverack.com is the only registered website for Claverack Rural Electric Cooperative.

Generate safely

To ensure the safety of our lineworkers, Claverack requires that backup power sources such as standby and portable generators must be completely isolated from the cooperative's power lines to avoid backfeeding electricity into the co-op's distribution system.

During an outage, lineworkers trying to restore power, or anyone who contacts a downed line, could be seriously injured or killed by backfeed from an improperly installed generator. WARNING!

Never connect a portable electric generator directly to your home's wiring.

Portable generators can be deadly when improperly installed. Claverack REC strongly encourages our members to have a licensed electrician install the equipment necessary to safely connect emergency generators.



Properly isolating your generator from the co-op's electric lines requires the installation of a double-throw transfer switch, which must be installed by a professional electrician.

The switch makes it impossible to connect the main power source to the generator. Its use is required by the National Electric Code when connecting an auxiliary power source to an existing system.

This voluntary program allows you to assist members of the cooperative who are experiencing difficulties paying their electric bills. Participating in the program is inexpensive – less than \$1 a month – and allows you to help make a difference in a neighbor's life.

CONTRIBUTING IS EASY

The concept is simple. Claverack rounds up your monthly electric bill to the next dollar amount. The difference between the round-up amount and your actual bill amount goes into our member assistance fund.

For example, if your electric bill is \$100.32, then you would pay \$101. The extra 68 cents goes into our member assistance fund for needy families of the cooperative.

In addition to being a great way to help neighbors in need, participating in the program can also make balancing your checkbook easier.
