From the President & CEO



It's a great time to be a co-op member

THERE'S a lot to love about this time of year. Warm weather, blooming flowers, extended daylight hours and a full season of summertime outings, get-togethers and outdoor activities lie ahead.

With the return of capital credits this month and the annual meeting coming up in July, it's also a great time of year to be a Claverack member.

In March, your board of directors approved a \$1.7 million return of capital credits to current and former members of the cooperative. This marks the ninth straight year that a capital credits retirement has been authorized, and since 2011, we have returned close to \$11 million in capital credits to members and former members.

Current members who were actively receiving electric service from Claverack in 1986, 2007, 2008 and 2018 will see a capital credits retirement reflected on their June electric bills.

Members who received service during the retirement years but who are no longer on our lines will receive a capital credits retirement check in the mail. We will also be returning capital credits to the estates of 198 deceased members who have requested a discounted return of capital credits in order to close out the member's estate.

We are able to return capital credits to our members due to our positive financial results. At the end of each year, if we collect more in revenue than we need to operate the cooperative, those excess margins are allocated to our members based on the members'

purchases during the entire year. These allocations are recorded in each member's account, and the allocations are paid to the member during the retirement process.

Another terrific event that takes place each summer is the Claverack Annual Meeting. This year's meeting will be held Tuesday, July 9, at the Elk Lake High School in Springville. Doors will open at 4 p.m., and members can enjoy barbecued chicken dinners in the gym from 4 p.m. to 6:15 p.m.

In addition to learning about your co-op's activities of the past year, plans for the future and director election results, members who attend also receive a \$10 bill credit and a chance to win some great door prizes at the beginning and end of the business meeting, which starts at 6:30 p.m.

We have also invited popular performer Van Wagner to take the stage in the auditorium again this year. Van, a talented singer, songwriter and teacher from central Pennsylvania, will perform at 5 p.m.

If you attended either of the last two annual meetings, you had a chance to experience Van's music, photography and passion for Pennsylvania history. If you haven't attended in recent years, please join us July 9 to see what you've been missing. ☀

Director elections slated for Zones 7, 8 and 9

DEMOCRACY will take center stage at Claverack's 2019 annual meeting, with director election results highlighting the agenda.

Board seats are up for election in Zones 7, 8 and 9 this year. This year's election of directors will be conducted via mail-in ballots. Each member will receive a ballot listing the names of all candidates seeking seats on the co-op board.

Members can expect to receive the ballots this month. The completed ballots should be returned in the addressed, stamped blue envelope included with the annual meeting notice. **Claverack must receive members' completed ballots no later than Saturday, July 6.**

The announcement of election results will take place during the business portion of the annual meeting.

In accordance with Claverack's by-laws, director elections take place on a rotating basis, with three zones up for election each year. Elected candidates serve three-year terms. Directors are responsible for establishing co-op policies and overseeing business operations.

Candidates who have filed petitions to run for board seats are: incumbent Charles R. Bullock, Zone 7; incumbent Charles R. McNamara, Zone 8; Anthony "Tony" Ventello and Frank Bertrand, Zone 9. A profile of each candidate follows:

Zone 7

Zone 7 serves members in Auburn, Bridgewater, Brooklyn, Dimock and Springville townships in Susquehanna County; Nicholson Township in Wyoming County.

Charles Bullock was elected to the Claverack board of directors in July 2007 and serves as acting chairman of the board.

A retired banker, he is active in the St. Joachim & St. Mary's Catholic Church, where he is a member

of the Holy Name Society, a former parish council president, and the current chairman of the finance committee. He is former treasurer of the Crescent Lake Association, and formerly served as the service unit chairman for the Wyalusing unit of the Salvation Army.

Zone 8 serves members in Franklin, Great Bend, Harmony, Liberty, New Milford, Oakland and Silver Lake townships in Susquehanna County.

Elected to the cooperative board in 2010, Charles R. McNamara earned his Credentialed Cooperative Director certification in 2011 and the National Rural Electric Cooperative Association's Board Leadership Certificate in 2012.

McNamara operates his own business as a "green" building contractor, with over a decade of experience in OSHA-trained commercial/industrial

construction safety. He specializes in the restoration, repair and relocation of antique timber frames used for private residences and businesses.

Anthony "Tony" Ventello is a resident of Franklin Township in Bradford County.



resided in Bradford County since 1977.

He is a retired lieutenant colonel with the U.S. Army Military Intelligence Corps, specializing in logistics and intelligence.

While serving active and reserve duty from 1967 through 1992, Bertrand and his wife, Sue, owned and operated a 200-acre, 40-cow dairy farm in Towanda Township. The couple raised their son, Michael, there. They were longtime members of Eastern Milk Producers, and Bertrand had served as president of the USA (Ulster, Sheshequin and Athens) local.

Following a barn fire in 1991, Bertrand transitioned from farming to the real estate industry. He earned both a real estate agent license and his certified general appraiser license in 1997 and continues to be a practicing appraiser.

PAiD program saves time, stamps, late-fee worries

If you are looking for ways to simplify your life, Claverack's Payment Automatically Drafted (PAiD) program may be for you.

By signing up for Claverack's automatic bill payment program, you can avoid the hassle of searching for stamps, filling envelopes and worrying about whether your payment arrives on time.

When you participate in the PAiD program, the payment for your electric bill is automatically drafted from your checking or savings account or charged to a credit or debit card each month.

Even if you are out of town, your bill will be paid on time. You'll never have to worry about paying a late fee again.

Here's what happens after you sign up:

- ▶ The first automated payment will be made the second billing period after we receive your completed form. The first month will be a trial run to verify account numbers. No money will be moved.
- ▶ You will continue to receive a monthly bill statement.
- ▶ Your bill statement will alert you to the date your payment will be automatically withdrawn.

With Claverack's PAiD program, paying your electric bill is simple. There are no sign-up charges or transaction fees. And you can cancel PAiD at any time by notifying us in writing.
