POLICY BULLETIN NO. B-12

SUBJECT: Penalties & Service Charges

POLICY:

The Cooperative may impose penalties and service charges that it deems necessary on any member who fails to comply with the rules and regulations, bylaws and policies of the Cooperative. These penalties and service charges shall cover the costs involved, thereby treating all members equitably.

RESPONSIBILITY: President & CEO or Delegate

PROCEDURE:

- A. The Board of Directors shall review the schedule of fees (attached) on an annual basis.
- B. The President & CEO or the Delegate has the authority to waive a fee or charge at their discretion.
- C. If a member experiences loss of power, breakers and fuses should be checked before reporting an outage to the cooperative. If a service crew is dispatched at the member's request, and it is determined that the Cooperative's equipment is not at fault, a service charge may be assessed at actual cost.
